The Point Richmond Neighborhood Council was honored in December to receive a \$2000 grant from the **Point Richmond Gateway** Foundation to help fund completion of the mural on the south portal of the Dornan Drive Tunnel. At our last meeting the PRNC Board voted to allocate \$700 from our treasury to complete funding of the project.

Safety Alert: At the November PRNC General Meeting, Officer Andretich stated that there has been a rash of robberies at the Richmond BART Station. Officer Andretich reminded us to be alert and aware of our surroundings while at the station.

Important Items at Next PRNC General Membership Meeting, January 30, 7:30 pm

Report on I-580 Repair Project: Work on the I-580 Scofield Avenue and Western Drive Bridge Deck Replacement project is scheduled to begin in January. Lane closures will likely not begin until March. A representative from Cal-Trans will be at the PRNC meeting on January 30 to give us the details and explain measures being taken to minimize inconvenience.

Marin Energy Authority: In May 2012, in a move to promote greater use of sustainable energy and retain local control of ratepayer dollars, the Richmond City Council approved a resolution to become a member of the Marin Energy Authority (MEA), a not-for-profit public agency which administers Marin Clean Energy (MCE).

Beginning in July 2013, MCE will provide a minimum of 50% renewable energy to all Richmond customers (unless they opt out), at prices comparable to PG&E. Representatives from MCE will be at the PRNC meeting on January 30 to talk about the MCE and answer questions about prices, energy sources, opt-out procedures, and plan options, including "Deep Green" – a 100% renewable option. Come to get first-hand information to help you as you make your individual decision regarding your energy provider.

General Meeting Minutes Wednesday, November 28, 2012

- 1. The meeting was called to order at 7:37 pm
- **2. Minutes of October 31, 2012 meeting were approved following addition:** Bruce Beyaert asked that the statement "The PRNC has applied for a Point Richmond Gateway Foundation grant to complete funding for painting of the mural on the south portal of the tunnel" be included as an addition to the minutes.
- **3. Police Report (Stephen Andretich sandretich@richmondpd.net) (Non-emergency number for police assistance 510-233-1214).** Officer Andretich reported that there has been an uptick in robberies in the past 60 days. Suspects tend to target people who are walking alone in the early morning, especially people talking/texting on the phone. The suspects are particularly interested in gold jewelry. We were reminded to be aware of our surroundings and report any suspicious behavior. He also reminded us that if we see street lights out to report this via the City of Richmond website under "Streetlight Reporting".
- **4. President's Report (Margaret Jordan, President 510-412-3673)** Margaret reviewed the updates from the newsletter. Writer coach connection is going well at Richmond High. Operation Ceasefire continues to gain momentum and Chief Magnus is a supporter. CPR classes are still looking for people who are interested. The Gateway Foundation will announce its funding decisions soon. There are several opportunities to donate toys. Mentioned was www.toyprogram.org and click on "donate" and toy drop off at Mechanics Bank. Next meeting is January 30, 2013 -- there will be no December meeting.

- **8. Report from Land Use Design Review Committee** No report. - **9. Report on Red Oak Victory Ship** (**Lois Boyle**) Rigger's Loft is being restored and this renovation has impacted the ship. Half of the dock space has been fenced off and the sanitation outlet has been lost so they have to pay for pumping. Utilities were off for a time, but are back on. Lois indicated that they have had to incur additional costs, but are working with the restoration team for Rigger's Loft.

Official sailing of the Red Oak is scheduled for 11/11/13. It is rated for 700 guests with a cost of \$150 per person to attend. Futures are for sale for \$20 each and 6 futures you will buy you the ticket for the initial sail, a savings of \$30.

10. Chevron Report on Placement of Monitor (Nicole Barber) Air monitoring program is recommending placement of the monitor in Point Richmond at the Natatorium. The website and the equipment is installed and operated by Argos, which is the company contracted for and managed by the City of Richmond but paid for by Chevron. The purpose of this is to get information to the community. Compounds monitored and levels are on the website.

It was recommended that the someone from the City of Richmond, Denny Larson, someone from Chevron, Veola and the CBE (Citizens for Better Environment) come to the PRNC meeting to talk to us about the monitoring program and results that have been compiled.

11. Report on Formula Restaurant Issue A meeting was held on November 26th, attended by Jeff Ritterman, Jeff Lee, Linda Newton, Kathleen Wimer, Sue Rosenof and Margaret Jordan.

It was agreed that the goal is passage of an ordinance that allows neighborhoods to ban formula restaurants in their respective C-1 districts. A proposed resolution has been created and sent on to Jeff Ritterman to submit to the Richmond City Council on December 5th, 2012.
