At our September meeting the membership voted support for renaming Western Drive NORTH of 580, Stenmark Drive. At its last meeting the City Council voted to make this change. We can expect to see a change in signage at the Pt. Molate exit on the freeway.

Important Items at the next PRNC Membership Meeting, Wednesday, October 30, 7:30 pm at the Point Richmond Community Center:

- Shea Homes Development of Bottoms Property: In July 2012, the PRNC membership approved (with a few conditions related to access and landscaping) the "concept" that representatives from Shea Homes presented for development of the Bottoms Property. Shea Homes submitted detailed plans for the project to the city earlier this month. On Tuesday, October 29, the City is holding a Public Scoping Meeting at 1160 Brickyard Cove Road, Suite 202, from 5:30 pm -7 pm. The purpose of the meeting is to receive comments on any potential environmental concerns that have not been addressed. On Wednesday, October 30, representatives from Shea will be presenting the project at the PRNC LUDRC at 6 pm at Interactive Resources (117 Park Place) and at the PRNC General Membership Meeting at 7:30. After discussion, we will vote on recommendations for the project. This will be a very important discussion. The city has created a website on the project with detailed descriptions at http://www.ci.richmond.ca.us/index.aspx?nid=2779.
- **Jim Matzorkis, Director of the Port of Richmond,** will discuss port development, including current and future contracts, planned upgrades, and other economic opportunities. Mr. Matzorkis will be available to answer your questions.

- 1. The meeting was called to order at 7:32 pm.
- 2. Minutes of August 28, 2013 meeting were approved.
- 3. Police Report (Sergeant Armando Moreno amoreno@richmondpd.net, (510) 965-4916) (Non-emergency number for police assistance 510-233-1214): Sergeant Moreno reviewed crime statistics for the past month. There is an increasing trend of stolen and recovered vehicles, 4 and 3, respectively. Honda Accords are vulnerable due to the fragile locking mechanism. Don't be an easy target. Even a properly installed "Club" can deter theft. Call the Police first about suspicious activity before posting on a community electronic forum.
- 4. President's Report (Margaret Jordan, President (510) 412-3673):
 - Saturday September 28 is the Picnic in the Point_to raise funds for Washington Elementary. Join us to help man our booth and jumpy house.
 - The new website for PRNC is on the way.
 - California Campus will be at our October meeting to collect your donated textiles and household goods (shoes, sporting equipment, books, games, etc.).
- **5. Membership Report (Charmain Tyler (510) 334-7267):** Member Drives continue a lot like NPR. We currently have 161 members.
- **6. Treasurer's Report (Garry Hurlbut (510) 547-8111):** General Fund \$8,900.28, Bishop Alley Fund \$711.06, and WigWag Fund \$2,970.94 (for which we are custodians). **Total Balance: \$12,582.28**
- 7. Report from Land Use Design Review Committee:

- **8. Marin Clean Energy (MCE) Update**, **Councilman Tom Butt:** Approximately 35,000 or 85% of households are now enrolled in Marin Clean Energy (MCE) in the city of Richmond.
- **9. The Renaming of Western Drive (north of I-580), Councilman Tom Butt and Chris Chamberlain**: There is a proposal to rename a portion of Western Drive to honor Captain Stenmark. Captain Stenmark was the longest tenured person at East Brothers Light Station, starting in 1895. There was general agreement that Western Drive, north of I-580, was confusing to drivers. The Point Molate Advisery Committee did not oppose. The motion to approve the renaming was approved, zero opposition.

- **10. Chevron Air Monitoring, Nicole Barber:** There is a two part program to install fence line and community monitors in Point Richmond, Atchinson Village, and North Richmond. The Natatorium was the 2nd location picked but historical significance rendered the location not fit for this purpose. The City and Chevron propose new installation at Washington Elementary (the Y care building). Installation should be complete before the end of the year. See the website at www.fenceline.org/Richmond for more information.
- **11. Report on Gateway Foundation**, **Jeff Lee:** Gateway Foundation is a community organization, in partnership with Mechanics Bank, that encourages Point Richmond enrichment through project grants. Gateway Foundation has given about \$75,000 since it's inception, including the Ferry Point Mural. This year's applications are due October 1. \$200-\$3000 grants are available.
- **12. Future of the Farmers' Market**, **Dave Schoenthal**: Mr. Schoenthal will not continue his one- man efforts next year for the Farmers' Market. He is asking for community involvement to help organize next year's Farmers' Market. A motion was approved to partner with the Pt. Richmond Business Association to make the Farmers' Market happen in 2014. We need everyone to help. Please call any board member to join.
