ON POINT May 2014

The first "Point to Point" event on Saturday, May 10, was a great success, with lots of fantastic art, good spirit, and good neighborly conversation. Watch for the next one.

Summer is Here! The first Point Richmond Summer Music Festival will be Friday, June 13, at 5:30.

Recently the PRNC has reviewed and made recommendations on two proposed construction projects. In addition we have discussed a controversial "Land Use" issue. Since we won't be able to hear updates on these projects of interest at the May 28 meeting, brief updates are below.

- The "Shea/Bottoms" Development is a proposed 60-unit development to be built south of Seacliff Estates. The major point of contention is building heights. The developers are asking that the current 35' height limit be increased to 50', significantly impacting the views of nearby neighbors and a public park. The Draft EIR (DEIR) proposes a General Plan amendment as well as rezoning to accommodate this request. The Design Review Board (DRB) has approved the project. The concerned residents spoke at a Planning Commission Study Session on May 8. The Commission will review and vote on the final EIR in June. City Council will likely consider the project and the request to amend the General Plan in July. Concerned residents will meet individually with the Commission and Council members to resolve the issue.
- A single-family residence is proposed at 70 Belvedere, by a possible buyer of the property. On April 30 the Design Review Board approved the design with the understanding that community concerns related to the stability of the hill and the construction work plan will be dealt with in the permitting process. The DRB concluded that maintaining the integrity of the Bishop Alley Path (a "condition" of PRNC approval) was outside their purview. Property owners next to 70 Belvedere will be appealing to the City Council arguing that the neighborhood has established an easement (historic right to access) across 70 Belvedere, and will request that the possible buyer's construction plan make a reasonable accommodation for the path. Neighbors are currently developing a comprehensive legal analysis (federal, state, and local law) to support the path easement across the property. - The General Plan designates "**Tiscornia Estates**" the area running along the downhill side of Pacific Ave. between Santa Fe and High Street as "Open Space." Recently realty signs have appeared. The land was apparently sold in auction and the individuals who bought it were unaware of its designation, which precludes residential construction. Residents in the area have come together to insure that the General Plan is upheld. A group of residents presented Planning Director Richard Mitchell with a petition with 162 signatures requesting that the City uphold the General Plan to maintain the area as Open Space.

Point Richmond Neighborhood Council General Meeting Minutes

Wednesday, April 30, 2014

- 1. The meeting was called to order at 7:37 p.m. and the minutes of the March 26, 2014 meeting were approved.
- 2. Police Report (Sergeant Armando Moreno amoreno@richmondpd.net, (510) 965-4916) (Non-emergency number for police assistance 510-233-1214) and PRNC Safety and Crime Prevention Report (Jon Sutinen, jsutinen@yahoo.com): Sgt. Moreno reported 3 recent burglaries. He highlighted that with warmer weather it is important to lock doors and windows before leaving, as it is the season of opportunity. He also said the thefts of packages left by Fed Ex trucks has been on the rise and neighbors should pay attention and report if anyone is following and taking the left packages from homes. Call with any information to help stop these crimes. John Sutinen attended a meeting addressing auto and identity theft and crime prevention through environmental design. We will have an officer come to speak at our meeting in the near future on these issues.
- **3. President's Report (Margaret Jordan, President 510-412-3673**): Margaret gave a brief explanation of Measure C, mail in ballot due mailed May 6. She also addressed the Minimum Wage issue that goes to City Council next week. Margaret encouraged us to attend the Cinco de Mayo events that are happening this weekend in Richmond.
- **4. Membership Report (Charmain Tyler (510) 334-7267):** Reminder to pay dues for May 2014-2015. We already have over 113 new or renewed members paid.
- **5. Treasurer's Report (Garry Hurlbut (510) 547-8111):** General Fund \$9677.31, Bishop Alley Fund \$711.06, and WigWag Fund \$2,970.94. **Total Balance: \$13,359.31**
- 6. Report from Land Use Design Review Committee
 - 0 Cliffside (Jeffrey and Jennifer Madden, owners) With variance at 3 points, recommended approval. Vote unanimous for recommendation
 - Terminal One Presentation (Paul Menzies, CEO Laconia Development) This was a study session, so no official vote, but it was asked that Laconia compromise to preserve views. Paul Menzies gave a presentation on this project, which is in the initial design process. They are gathering opinions and ideas. The concept is currently a 326-unit project with 4,5 and 6 story structures, 2-3 story townhomes and mini villas (2400 sf average size) on a 13 acre site. Mr. Menzies fielded many questions from the audience following his presentation. Laconia will return to the PRNC as the project progresses.
- **Items to be considered at the Committee's May 28, 2014 meeting must be submitted to Rod Satre, Committee Chair by May 8, 2014. Contact Rod at rdsatre@live.com or (510)232-5059. - **7. Election of PRNC Officers -** Margaret Jordan for President unanimously elected and Noelle Harmon for Secretary, unanimously elected.
- 8. Update on Tiscornia Estates (Ralf Morgan) Ralf gave an informative history to the Tiscornia Estates Specific Plan and discussed the threat to its open space provisions. The property was purchased in the 1980's by Leonard Gross/Del Mar Commerce with the intent to create a high density development. After objections from the neighborhood, an EIR was commissioned by the City. The result was the Tiscornia Estates Specific Plan (TESP). The EIR deemed that a significant portion of the plan area should be dedicated to open space and the rest made available for restricted development. TESP was passed by the City Council in 1986 and subsequently amended in 1988. More recently, the TESP was incorporated in the 2030 Richmond General Plan. Under the 1988

revision, Mr. Gross was given some benefits including, but not limited to, rights to some paper streets and properties. He accepted these benefits. The Tiscornia Open Space map was revised to reflect the concessions to Mr. Gross/Del Mar Commerce along with a few other changes. Mr. Gross retained title to the open space properties. He continued to pay taxes until 2009. Mr. Gross has passed away. Recently, Contra Costa County sold the delinquent properties at a lien sale. The lots were sold to speculators. The lien sale properties are clearly shown as dedicated open space per the 2030 General Plan and in TESP. Two properties are currently for sale. A community group has been formed, called Friends of Tiscornia Estates Open Space (FOTOS), with the goal to encourage the City to keep its promise of open space. FOTOS is asking for PRNC support of the Tiscornia open space provision. Currently the group is circulating a petition, which will be submitted to Richard Mitchell, head of City Planning Department. Mr. Mitchell was invited to the meeting, but did not respond to the invitation. Don Mill, who stated he was in contract for one of the open space lots spoke, questioning the open space. Questions from Mr. Mill and the audience were answered.

9. Update on Shea Homes (Kathryn Dienst) Kathryn updated us that the next step in this project is that it goes to the Planning Commission. The EIR closes May 12th. The Mitchell Memo has been rescinded. An Abuse of Discretion has been filed against Mr. Mitchell. Shea Homes is now seeking an amendment to the General Plan to achieve their goal of exceeding the 35 foot height limit. Shea will be making a presentation to the City in June or July. An attorney hired by a concerned group of neighbors will be reviewing the EIR.
