They continue to work closely together to improve emergency response and safety plans for everyone in the Point and city-wide.

Meeting Called to Order: 7:35 PM

Correction to Minutes:

Buzz stated that Norma Jean Wallace clarified that she contacted RPD twice. The first time was with the license plate detail. The second time she was told it had been cleared. She then asked to speak to the supervisor, who advised her that the car was registered on her street so there was no problem. Norma updated RPD that her neighbor had found feces and urine in their carport and if the driver lived there, why would they use a carport as a bathroom? RPD advised they would check again. Norma would appreciate this detail being included in the minutes as pertinent to the RPD.

Diane from Women's Westside Improvement Club said their meeting is on Sept 12th.

Approval of Minutes: Philip made motion to approve minutes with these corrections; Leisa seconded; minutes unanimously approved with above change noted.

President's Report: Philip Rosenthal

First, did anyone find it useful to receive a second copy of the Zoom link in their email box this morning? Yes? So, that's a winner, we will continue sending it out twice.

I wanted to congratulate Cesar Zepeda and tell him how grateful we, the elementary school and their neighbors are for his two-week turnaround in traffic safety concerns. After eight years of begging, with Cesar's and Public Works' help, they were able to get the curbs around the school painted. And Cesar tells me that they are scheduled to do the crosswalks before the start of the school year.

Cesar also mentioned that he is working with Chief French to install radar speed signs by the entrance of the tunnel next to the tennis courts. He's also working on repainting the crosswalks all around the Mechanics Bank and around the Plunge. So, if you see Cesar, shake his hand and tell him how grateful we are.



The National Night Out will be this coming Tuesday (8/1) from 5:30 to 8:30 PM on Park Place. There will be music, and it is Taco Tuesday by Josephine Orozco, who along with Peter, have arranged to display some of their cars this year. This is a good time to get out and meet your neighbors. Please encourage folks from your church or your customers to come out.

Also, we're on vacation next month.

The next special meeting will be three parts -- on crime and homelessness, in general, and how those two things might be connected; we're also going to discuss the traffic backups as much as the local police can control them, which is not much, but at least we're going to discuss how dangerous this is for our community. And Michelle Milam is going to remind us how we can start a citizen crime watch both formally and informally. And the second special meeting we are working on will be with Rocky Saunders and Leisa Johnson about fire safety (and a summary of the community surveys and lessons learned from the Brickyard Cove emergency evacuation drill).

Police Report: Officer Cedric Tagorda

I apologize. I just got the email and have been busy. I had to try to do a crime analysis, hopefully this will be sufficient.

Most recently there was a robbery and an alleged robbery yesterday at the Point Richmond Market. A suspect stole a beer. The owner chased the guy, although I've told him not to do that because these guys are armed and it's dangerous. The suspect pointed a firearm at the store owner. We arrested the suspect. It's a petty theft that turned into someone pointing a firearm.

We'll start off with the top five areas that get the most calls, like a lot.

- Number one: 915 West Richmond, Todd Hotel. Regular service calls like someone not paying their bill or arguing or someone mentally ill. Nothing serious, just John (the manager) calling when he can't handle someone confronting him, so he's a big problem.
- Number two: 135 Park Place -- a burglary break-in & stolen cash.
- Number three: I-580 and Canal Blvd -- homeless related transients.
- Number four: I-580 and Castro we are called because of people making illegal U turns.
- Number five: 150 Washington Ave -- illegal parking and transients.

Point Richmond area as a whole, compared to this City, is not doing bad. We get a lot of calls for transients, homeless issues, and abandoned vehicles, but it's not that bad.

21 calls for service at 915 West Richmond in the first month and another 17 calls a service this month. The manager, John, is part of the problem. Everything else has been false alarms. Then, there was the call on Sanderling Island.

Leisa: Curious about the cleanup of the encampment on Caltrans property.

Officer Tagorda: Caltrans is aware of the issues along the railroad tracks, anytime you are encroaching into the tracks, they try to do what they can, and we work with Caltrans. They're trying to get that area cleaned up, all along I-580. We're trying to get the RV's out of the area and deal with the people that live in their vehicles along residential streets.

Leisa: Any updates on the person that was killed on I-580 near Canal?

Officer Tagorda: There was a man walking on Interstate 580 Tuesday morning who was killed by a pickup truck at 3:26 am. When there are problems with on-ramps and off-ramps, we are supposed to call Caltrans and CHP. There has always been an issue between CHP and RPD because of jurisdictional lines. So, if it's freeway safety, or it



happens on the on-ramp, it's going to be CHP; but the closer it gets to city streets, more than likely it will be handled by RPD.

Leisa: So, should we call RPD first?

Officer Tagorda: You can call Richmond PD or you can call 911 and somebody will respond and determine whose jurisdiction it falls under.

Philip: Do 911 calls made from a cellphone go to the Highway Patrol anyway?

Officer Tagorda: Yes, if something happens in Richmond, don't call 911 as that gets sent to the Golden Gate office and they must send it to us. So, you want to go directly to our dispatch.

Treasurer's Report: Margi Sullivan absent

Membership Chair: Eric Napralla - We currently have 165 paid and active members.

Richmond Fire Department: Brickyard Cove Emergency Evacuation Drill Report & Annual Firewise Refresher

Leisa: We had a very successful fire drill on July 15th with over 66 vehicles and 100 participants. A strong turnout for this second drill. There were lessons learned, first and foremost: people had issues signing up, while other people didn't receive the alerts; and our zone on Zone Haven excluded people in HOA 2, people that live on the Spit, which means those people didn't get the alerts. The city is working to rectify this. Still, some people were able to participate because they knew what was going on even though they didn't get the alert.

It's extremely important during drills to improve the communication processes. Clearly, there are still deficiencies, but overall, it was a success. And as I alluded to earlier, we are scheduling a more detailed debriefing with the West Contra Costa Fire Safe Council to address evacuation issues. These are not just restricted to fire. If there's a hazardous material or train issue, evacuation routes are critical. So, we need to put pressure on our city council, Cesar and the rest of city staff, to make sure they honor CEQA and the mitigation measures that were approved in 2008 to properly protect the community, to allow prompt ingress for our emergency vehicles as well as egress for residents, workers and students in case of an emergency. There will be a future meeting to cover these issues with the City.

Rocky Saunders: Another aspect of the drill was the use of ham radios and GMRS radios. As we all know, there's a hill between Brickyard Cove and the rest of the world, towards Richmond.

Leisa: We have a new YouTube channel with recordings of all our PRNC meetings for about the last year plus. We will share the link and have it go live with everybody here shortly. And we will be posting all our future meetings there so that anybody who was not able to attend can do that. We will send a special announcement about this. This way people can be more involved. And we can even monetize it, so maybe we will get some money coming in for the PRNC. Please stay tuned.

Philip: Now, updates from the Fire Inspector.

Fire Inspector Dante Wiley: I've been with the Richmond Fire Department for 11 years. I've been serving as Fire Inspector for the past five. Regarding the evacuation drill, in fire protection talk, there are six Ps of evacuation.

- The **first P** is people; if possible, pets.
- The **second P** is paper -- hard copies and electronic copies of insurance and other vital documents.
- The **third P** is photos, irreplaceable mementos, and other priceless items.
- The **fourth P** is plastic payment (credit cards) for emergency expenses.

- The **fifth P** is a personal computer or laptop to access electronic files and stay connected.
- The **sixth P** is pills and prescriptions, including vitamins, medication, and medical devices.

Richmond has two areas of very high fire severity, Point Richmond being one of them.

I now want to talk about **home hardening** -- the process of making sure that your house is as safe as possible.

- Embers can start from bonfires on Keller Beach or fireplaces, so check the spark arrestor on the top of the chimney on your residence.
- You need to maintain your gutters. Leaves from trees can clog gutters, creating fuel for embers which can travel upwards of five miles and start a fire.
- There are **three zones**:
 - **Zone zero** is within 10 feet of a structure that's on your property.
 - You want to make sure not to have any combustibles (e.g., bags, wood, chips) leaning directly up against your structure.
 - If an ember does land in those combustibles or your garbage, you can have a fire start and spread to the interior of the structure.
 - Remove all dead vegetation.
 - **Zone one** is 10 to 30 feet from a structure.
 - You want to maintain the vegetation surrounding your property
 - Remove all dead vegetation
 - Fences and deck materials should utilize noncombustible materials currently on the market.
 - You want to keep this area **lean, clean and green (our mantra)**.
 - **Zone two** is 30 to 100 feet from a structure.
 - You want to reduce the fuel load.
 - You want to maintain separation distances between trees.
 - You want to maintain your vegetation within a height of **no higher than five feet**.
 - Remove all dead vegetation.
- Fire season used to be six months, but is now about nine months.

Questions?

Amanda Bruun: Any specific recommendations for working with HOA's or multi-unit & multi-family housing?

Fire Inspector Dante Wiley: If there are any issues, the fire department does come out and do defensible space inspections and provide their findings to the HOA or ownership of the property to get them to comply.

Eric: Are these recommendations, voluntary, or are you or the City / Code Enforcement proactively identifying these issues?

Fire Inspector Dante Wiley: We get complaints from concerned citizens about certain properties, and we have 48 hours upon receipt to investigate. This information goes out as a suggestion of what should be done to maintain and protect your property. From my knowledge, Code Enforcement has not gotten involved. It is all done by the fire department, and mainly the fire prevention services division, of which staffing is a little low, to say the least. So it will be myself or Acting Fire Marshal, Eric Munson. You can feel free to call me if you have any questions or concerns about your personal property or within your neighborhood. Don't hesitate to give me a call.

Leisa: Can you comment on the brush around the Ferry Point tunnel? How can RFD help us make sure that BNSF promptly and appropriately addresses their overgrowth in that whole area in an annual manner well before fire season?

Fire Inspector Dante Wiley: I believe two years ago BNSF cleared all the way along the tracks and up to the tunnel. The fire marshal had made a lot of headway with the connections at BNSF. Unfortunately, the fire marshal has been out for about eight months now, and I don't have the same contacts that he does. But I will push this up the chain to



the acting fire marshal to try and get this on the schedule because I know there's a lot of vegetation which is a fire hazard.

Leisa: Every July is our annual firewise refresher for people. The president of West Contra Costa Fire Safe Council (WCCFSC) is also working to get a second red flag sign installed for the Point Richmond area. So that will also be covered in this future meeting by Soheila and the WCCFSC to get that in place in our area in Richmond.

Community Briefs, Part 1

Richmond CERT: Charmain Tyler

Richmond CERT had people present for the Brickyard Cove evacuation drill. We helped monitor traffic, talked to the people who were evacuating, and a lot of them had a lot of questions. They were smiling and happy and thought it was helpful. We started at the Brickyard clubhouse, then to the assembly point at the old Shipyard Cafeteria. There was RFD and RPD to help. We tested radios. One of the things that CERT does is to ensure there's communication if cell phones and landlines are down. That's why we always emphasize radios. Some are for a short distance, a couple of blocks. And other radios that are good for much farther. We try to communicate with the Richmond Civic Center downtown, the main center of operations in case of emergency or disaster like an earthquake. So, we can contact the fire department and police department and relay messages back and forth. Brickyard Cove is unique because most of the radios can't go over the hill, so we need taller antennas, or relay radio messages.

We're also talking about training dates for the fall, though we don't have a schedule yet. We're going to try for September.

Point Richmond Business Association (PRBA): Josephine Orosco

I appreciate all the information from the RPD and RFD on how businesses can be more involved regarding the evacuation drill.

For the National Night Out, thank you for doing this. I love people who have plans to do things like this, and I'm happy to be part of it. We arranged for four vintage cars, all members of the Old Northern California Cruisers from Pinole along with Peter's cars. Along with our taco stand, we're promoting our Filipino cuisine as well. Regarding logistics, what time should the cars come?

Philip: The event begins at 5:30 PM. We want to be set up by 5:00 PM. So, why don't you and Peter touch base by email.

Josephine: I am a board member for the Masquers Playhouse and we're going to share a tent with them to promote their plays and opening days. Also, the PRBA is sponsoring the Fall Fest in October. I just sent an email to you (Philip) and Peter, calling for participants and volunteers to join a ZOOM meeting to figure out what we need everybody to do to be part of the Fall Fest, similar to what you did for National Night Out.

Philip: I can speak for PRAM to thank the Hurlbut Foundation, who helped with the gardening and removed the blackberry brambles.

HOAs in Brickyard Cove:



Rocky: At Brickyard Landing, my role is planning for emergency preparedness and we are looking at formulating our annual evacuation drill.

Leisa: One issue Rocky and I as well as Jonathan Livingston spoke about with Councilmember Zepeda is a waterborne-based evacuation if the community can't evacuate because of fires or a railroad incident. There are a lot of people that have boats, and one thing we considered taking on in the future is trying to figure out something around this if the City can't make this happen.

Philip: When we had the discussion about this meeting, WCCFSC suggested we focus only on Brickyard Cove. But I persuaded them that if there's an evacuation out of Brickyard Cove, it's going to come through the tunnel and we need to encourage the whole Point Richmond community to get out of their way because of the physical constraints and special circumstances that the residents and workers in Brickyard Cove face.

Norma Jean Wallace: During the Loma Prieta earthquake, I saw ferry operators using maritime radios and focused on evacuating people from the Ferry Building. I think this could work for Brickyard Cove; a ferry could use the existing landing dock and evacuate 300 to 400 people at a time.

Land Use Design Review Committee (LUDRC): Charmain Tyler

The LUDRC email address is LUDRCPointRichmond@gmail.com. Last week we had a meeting and Rod is working on a letter to the city. He asked the community for comments so people can voice their opinions and suggestions about the Keller Beach sewer line project. Write to LUDRCPointRichmond@gmail.com. It will go straight to Rod.

Graham Perrett: This is a huge deal for Point Richmond. \$95 million, maybe. I don't think there's any other potential project now outstanding here in Point Richmond of that size. We're talking about digging up Western Avenue, one of our three evacuation routes. And people are going to be looking at maybe paying \$75,000 to get a new pump for this new system as it is currently proposed. Unless we move quickly, the bureaucracy we're dealing with will become fact, and it will be too late to change it. Cesar, have you had any meetings about this?

Councilmember Cesar Zepeda: We had a meeting with Public Works and the CEO of Coastland they hired and went over their scope of work and could see where there was confusion. We are having conversations to make sure that they are looking at three options. Everything's moving slow, unfortunately, but I'm still meeting with Public Works. I'll follow up with them tonight.

Richard Johnson: I wanted to echo Graham's points. There's some concern with Coastland and the broad scope of work that they're doing. Hopefully they will consider other options at this town hall meeting. They were adamant this was the only option and said it's a slam dunk, and other options were impossible. A lot of the meeting was focused on trying to understand what Coastland is doing. Hopefully Rod will be able to get information from the City and share those facts in advance to facilitate productive conversation.

Councilmember Cesar Zepeda: This has been like pulling teeth. No matter what Coastland proposes, we are going to ask for a peer review. Unfortunately, the City Council is on break, so I can't bring anything for the agenda until we come back. I've already let them know over email that we want a peer review of whatever Coastland comes up with. We need time to get someone to come in as an expert, based on their expertise, and not just because they were doing other nearby projects.



Vivien Feyer: I wanted to reiterate that in addition to all of the questions being asked of Coastland and all of the reporting that they're doing, it seems like during the last meeting that we were all in agreement that it would be helpful to urge the City to start looking at other companies, other consultants, other plans, other than critiquing Coastland's plan – really looking at some different ways of approaching this problem.

Community Briefs, Part 2

Richmond Neighborhood Coordinating Council: Cordell Hindler

This month's meeting we had 27 people in the ZOOM. The City departments gave a report and said that the Neighborhood Councils can utilize the community centers again. Our featured presenter was RFD Inspector Dante Wiley, giving an overview of the duties of the fire inspectors. I brought to the board that they consider inviting a non-profit organization called Community Villages, who they presented at the Juneteenth festival.
