## THE HOLIDAY SEASON...

## Republic Urban Housing Development Update...

On November 13<sup>th</sup>, Brickyard Cove Alliance for Responsible Development (BCARD) was informed by Councilmember Zepeda that PG&E had terminated their contract with Republic Urban Properties (RUP) for a proposed residential housing project on PG&E's land in Brickyard Cove.

RUP formally notified the City and BCARD on November 17<sup>th</sup> that they would not be moving forward with their housing project or the City Council appeal hearing on January 16<sup>th</sup>. BCARD is awaiting formal confirmation from the City.

### Reflecting on 2023...

The PRNC board has worked hard this year. We have seen baby-step improvements in traffic calming efforts and hope to continue the momentum with more substantial improvements. We have sponsored and participated in several downtown festivals and events and will continue to support an increase in activities in our community.

We are constantly working with police and fire to bring our public safety concerns to the attention of the City. Likewise, we are in constant communication with the Public Works department to keep the maintenance needs of our neighborhood in front of City staff and management.

We are also in regular contact with Councilmember Zepeda, who, although he has a surrealistic number of neighborhoods in a vast district, always responds to our calls in a timely manner.

The holidays are upon us, and for those who celebrate them as religious, festive, both...or not at all...I think I share the universal wish that our neighbors find calm, joy, and peace as winter settles in.

#### **Call to Order and Approval of Minutes**

- Minutes from September 27, 2023 meeting
  - o Correction noted Women's Westside Improvement Club (WWIC): Club membership is \$20 per year for members and \$10 per year for friends of members.
  - Motion to approve minutes (Philip) and 2nd (Leisa)

#### Police Report: Sergeant Cedric Tagorda

#### Crime Analysis Statistic - Report time frame: 9/28/23 - 10/24/23

- 14 incident reports
- 208 (aggregate) calls for service (mainly suspicious vehicles or persons)
- Top 5 locations:
  - o Baltic Kiss (13 calls)
  - o 53 Vine Ave residence (7 calls)
  - SureStay hotel (6 calls unwanted persons)
  - Mechanics Bank (6 calls unwanted persons; parking issues)
  - Tewksbury/ Castro (5 calls commute traffic, unwanted persons, homeless)
- Anytime a vehicle is involved in a carjacking, the Police Department receives an alert.
- Gary Hurlburt: Are businesses having more issues with shoplifting? (i.e. we're all aware of what's been happening in the news, people just walking in and taking items).



- Per Sergeant Tagorda, many times officers' hands are tied. It has gotten worse in Richmond as shoplifting is up everywhere in the Bay Area. For example, Walgreens on Macdonald is thinking of leaving.
- There have been reports of thieves going out the fire exits at Grocery Outlet and Marshalls with armfuls of merchandise.
- o In general, Police Officers will not chase these thieves as, if they were to get hurt during the pursuit, they could sue the PD.
- The Police department is hiring several new officers and will have them in training shortly; also looking to hire another five by end of year.
- There was a car going the wrong direction on 10/17 on I-580 near Canal around 8 or 9 PM; 20 Sheriff officers responded.
- Leisa Johnson: Sergeant Patchin posted on NextDoor that RPD will be increasing/enforcing ticketing and/or towing of abandoned and illegally parked vehicles throughout the City.
  - RPD works with the County's Coordinated Outreach Referral Engagement (CORE) to offer services and help relocate people sleeping in their vehicles. By law, they cannot have them move if they can't offer them a place to stay. Currently, all but one shelter is full.
- Philip Rosenthal: Area in front of the Plunge has had consistent drug dealing. Along Railroad Ave there is a truck belonging to the owner of the Todd Hotel with expired registration tags. There is also what appears to be a very large, abandoned vehicle by the school on East Richmond Ave.
  - If permitted, given our Police cannot be everywhere at once and are addressing more urgent matters, members of the Point Richmond community are open to assisting our PD by leaving Police-sanctioned notes and/or 72-hour notices to move on illegally parked or abandoned cars in our neighborhoods.

- **Crime**: NextDoor, Facebook and other Social media to be used to pass on Crime & Safety meeting information from Crime Prevention Manager Michelle Milam (meeting 11/6 at 7 PM via Zoom).
  - Discussing crime in general
  - How to respond to drug and mental illness calls. A list of contacts re who to call when responding to these
    events will be provided as it is critical that the correct procedures are followed.
    - Late this year/early next, PRNC will provide information to Point Richmond both via mail and on-line.
  - o How to organize formal/informal Neighborhood Watches and what we can do safely as citizens.
- Judge Carroll Park: Discussions with Parks dept. to make it a little more flexible. They may have funding for a separate dog park and a separate soccer field.
- **Ferry Point Tunnel Call for Sponsors.** Sponsorship opportunities for new interpretive display signage to be installed in front of the Ferry Point Tunnel.
  - This new sign will highlight the history of the tunnel, a significant landmark in Richmond, and the names of generous sponsors who made the mural and signage a reality. It will also include the background of the PRNC and its significant contributions to the community.
  - The signage will enhance our sense of community and add to the general knowledge of this historic part of Richmond.

#### Conversation with our District 2 Councilmember: Cesar Zepeda

00:34:38

- The PRNC appreciates Cesar taking time to attend this meeting.
- Graham Perrett: What is the follow up on the Keller Beach Sanitation System project?
  - The "Sewer Subcommittee" meets monthly; last shared that staff is committed to bringing a consultant in to do a peer review to look at all options as the Bay Keepers letter offers different options to consider.
  - o The City is hiring a person to better communicate/connect with the community.
  - Cesar would like to add a City Council item to not move forward with any one option until all options have been reviewed. He will apprise the PRNC when it will be on the Council agenda so the community can attend or call in to voice their opinions and obtain answers to outstanding questions.
  - The community's concern if the pipeline breaks in the imminent future, the City may choose to go with the only solution they've examined thus far.
- Garry Hurlbut: There were some mature trees that were considered for cutting; could any be saved and/ or possibly replaced?
  - Cesar spoke with Prologis and, per their report, the trees were to be looked at by an arborist. They were deemed not healthy and would later be replaced.
  - o They removed 12 15 trees; may be planting 30 40 (along the sidewalk and within parking areas).
  - o The trees on the median, except for one, should have been left alone.
- Regional Measure (RM) 3: Finance a comprehensive suite of highway and transit improvements. Roughly \$170M in funds to be released to Richmond in January 2024:
  - \$10M going toward bike lanes
    - Caltrans conversation(s) likely to come in November re bike lanes and potentially using Zipper lane to open/close.
    - PRNC would like our bike lanes redone to where they were when they were originally approved.
  - Some funding will be used for Bridge restructuring/ toll lanes to make it easier for people to cross and not having cars merge.
  - Richmond will be partnering with Marin County re the back-up issues on 580; would like to see equity between Richmond and Marin with relation to the amount of money each is receiving from RM 3 (Marin receiving more) when dealing with this issue.
  - Roughly \$75M to be used toward Richmond Parkway- will want community feedback and a plan will
    eventually be drafted and shared.
    - PRNC would like to know when there is a call for feedback so the community can attend and share their perspectives/ concerns.
- Leisa Johnson: There was another Veolia H<sub>2</sub>S alert tonight; there have been several H<sub>2</sub>S spikes & alerts over the past few months that Veolia has not adequately addressed.
  - o Cesar is in constant communication with City staff and Veolia re: this ongoing problem. The City and Veolia are still performing infrastructure upgrades to the plant.
- Jeff Ritterman: Any plans to repave City streets?
  - The budget is \$4M; it could cost up to \$40M to repave the entire City. It may be brought up during the next budget session.



Rich City Rides: Najari Smith

- Currently have a petition circulating online to keep the walking trail on the bridge; 2,600 signatures to date.
- RCR has been advocating for bike/walking trail on the bridge since its ribbon cutting. There is a need to make the barrier more visible.
- Would like to see Richmond maintain this Regional asset, as it connects to the Bay Trail
- RCR is in support of a Zipper lane and more parking spaces; we have a safety crisis
- Seeking a letter of support for the RCR campaign supporting a bike trail on the bridge. In general, the large number of cycling groups coming through Point Richmond have been good for local businesses.
  - What % of petition signatures are actually coming from Richmond residents?
  - o Does RCR receive funding from the State but not from the City?
    - Najari will come back with firm numbers.
- Jessie West: Concern about potentially providing a letter of support at this time. This should be a considered only as the result of a vote. Will add to agenda at a future meeting.
